Rehearsals: Friday, December 12 6:30 p.m. - 9:00 p.m.
Saturday, December 13 8:30 a.m. - 3:00 p.m.

Concert: Saturday, December 13 4:00 p.m.

Requirements:

1. All directors must be current members of TMEA and hold a valid membership card. A **copy of your card** must accompany your entry.
2. All directors entering students **must be present** and **willing to participate** in the auditions and activities of ANY and ALL TMEA Region 24 events, which include: sectionals, rehearsals, concerts, and all high school **and** middle school region events.
3. Do not enter students who expect conflicts of any kind or length of time during the scheduled rehearsal times. Students will not be excused for doctor's appointments, soccer games, family reasons, etc.
4. Please remind your students that the State Eligibility Rules apply to their participation in the All-Region Orchestra. Students must be passing all courses in order to participate.

1. The checklist from the entry program (please remember to verify and initial).
2. The printed entry with Director's Statement of Responsibility.
3. Summary sheet.
4. A copy of your TMEA membership card.

6. Hard copies must be postmarked no later than **September 27, 2008**.
